A quorum being duly present, Chairperson Cronin called the January 23, 2025 Hyannis Fire District Commissioner Regular Meeting to order at 7:02 PM

I. OPEN SESSION:

1. MINUTES:

- Upon a motion duly made and seconded it was voted to approve the minutes of November 14, 2024, as amended

3. PUBLIC COMMENT:

4. STREETLIGHTS:

- Chairperson Cronin stated there were a couple of emails received recently; she inquired if Commissioner Atsalis had been able to review these emails yet.

4. STREETLIGHTS (continued):

- Commissioner Atsalis stated he had been able to process these emails regarding streetlight requests on Suomi Road, Dunn's Pond Road, and Sea Street
- Commissioner Atsalis traveled to Suomi Road to see the current streetlight design; he will follow up with the Suomi Road neighbors to make sure there is a consensus so that the HFD board will hopefully avoid causing any unforeseen streetlight issues with the proposed streetlight changes
- Commissioner Atsalis said he needs to review the Dunn's Pond Road situation as the requestor's sent a follow-up email with more details
- Commissioner Atsalis stated the last email concerning the Sea Street request was denied as the neighbors decided they did not want the proposed streetlight.
- Commissioner Atsalis notified the email requestors of the streetlight request status and any final streetlight decisions

5. OLD BUSINESS:

6a. BUDGET

- Assistant Chief Dardia said Chief Burke will have the Budget draft for the next meeting for the board's review; all other Budget items are currently on track and in process.
- District Clerk-Treasurer Menesale said the retirement assessment increased by \$200k; this increased assessment item will impact the Budget; this item has to with the COLA (Cost-of-Living Adjustment) that was retroactive in 2022; this item is in the Budget under the Retirement Assessment line.

6b. ELECTIONS:

- Chairperson Cronin stated the nomination papers have been handed out; Both Commissioner Alex Mercado and I, are running.
- Chairperson Cronin has not heard anything definite regarding the moderator position which is open this year due to the resignation of Mr. Lobell; although, there was one person who was asking about the moderator status but have not come forward.
- Chairperson Cronin said if the moderator position is not filled before the Annual Meeting, then the moderator can be elected from the floor as in previous years.

6. NEW BUSINESS:

- Commissioner Skende asked if Commissioner Cross and District Clerk-Treasurer Menesale will meet with our Hyannis Fire District's attorney who attended last year's meeting, to discuss the streamlining of the Annual Meeting where we can.
- Commissioner Cross said he touched base with District Clerk-Treasurer Menesale about the Annual Meeting streamlining options; Commissioner Cross and District Clerk-Treasurer Menesale will meet up next week to discuss this item; the meeting will be via ZOOM, any proposed language changes will be reviewed by our attorney's before finalizing.
- The board discussed the importance of the Annual Meeting's language and to make sure the information is clear and the language is precise.

7. BUILDING REPORT:

- Assistant Chief Dardia stated there are no known issues with the building; the ramp is going well; the new decontamination sink is working well.

8. ITEMS NOT REASONABLY ANTICIPATED BY CHAIR:

- None

9. CHIEF'S REPORT:

- Assistant Chief Dardia thanked the board for its attendance at the January 14th Recognition Ceremony; the board's attendance means a lot to the FFs; it is quite a bit of work organizing this event, but it is a special and valuable ceremony for the FFs
- Assistant Chief Dardia said the scheduling of this event is complex as there are so many limitations due to the board's scheduled meetings and elections and the other obligations of the HFD; going forward, the Recognition Ceremony's scheduled date may need to change to accommodate as many family members.
- Commissioner Cross suggested to Assistant Chief Dardia to ask the HFD Local Union 2127 leadership for a date direction as there are only a few months a year that they could have this award ceremony as there are so many obligations and other factors affecting this award ceremony date.
- The board discussed the importance of this event and the complexity of scheduling it
- Chairperson Cronin, Commissioner Cross and Commissioner Skende stated the Recognition Ceremony was a well-executed event; the board thanked Assistant Chief Dardia for his and his team's efforts in planning and

executing this complex and vital ceremony

9. CHIEF'S REPORT (continued):

- Assistant Chief Dardia, per the Chief Burke's direction, is seeking the board's approval to pursue 2 conditional offers to 2 candidates; both of these candidates have completed the Fire Academy training and they both are certified EMTs; if the board approves Chief Burke's decision to offer these 2 candidates conditional offers then these 2 candidates will start in March 2025 and be targeted to be ready to begin, by July 2025.
- Upon a motion duly made and seconded it was voted to approve Chief Burke offering 2 conditional offers to these 2 candidates:

- Assistant Chief Dardia stated the HFD Local Union 2127 has approached Chief Burke to start talking about the HFD promotional policy; the HFD Local Union 2127 is thinking of possibly limiting the number of candidates moving forward as the testing can be costly; Chief Burke will discuss with the HFD Local Union 2127 leadership how to best streamline the HFD promotional policy in the most cost-effective way; then Chief Burke will bring the proposed HFD promotional policy changes to the board for its decision regarding these proposed changes.
- The board thought it was a good idea for Chief Burke to meet with the HFD Local Union 2127 to discuss the proposed HFD promotional policy changes to bring before the board.
- Assistant Chief Dardia stated the HFD received the equipment grant, the Commonwealth of Massachusetts granted the HFD about \$19k.
- Assistant Chief Dardia put in for approval on the new ballistic equipment; the HFD first purchases the
 equipment and then the grant will reimburse the HFD the equipment cost; this request for equipment will buy
 12 full ballistic equipment sets; this equipment request must be fulfilled by June 25, 2025.
- Chairperson Cronin asked if this grant is sufficient to cover the ballistics need and Assistant Chief Dardia said
 he thought it would cover the HFD's current ballistics need, but he is looking to see if the HFD can find more
 long-lasting ballistic equipment.
- The board thanked Assistant Chief Dardia for his efforts in applying for and receiving this grant for the HFD
- Assistant Chief Dardia stated the recent cuts to the Governor's Budget does not affect the HFD.
