4. STREET LIGHTS:

- Commissioner Atsalis said there has been a request to check the lights at Angell Road off of Sea Street
- District Clerk/Treasurer Menesale stated that Constellation, which is the deliverer of Eversource's supply, has acknowledged the receipt of her recent email regarding the light map request, District Clerk/Treasurer Menesale is looking into the possible savings available. District Clerk/Treasurer Menesale is checking on which lights are being paid for by the Hyannis Fire District
- District Clerk/Treasurer Menesale updated the board on her findings from her research she did to more fully understand the expenditures and other factors which affect the overall cost of the streetlights

6a. Building Report – Chief Burke stated the short-term note will cover the call assist button which will be installed in the station's downstairs lobby and outside the station, this improvement is expected to cost \$2068.82

8. CHIEF'S REPORT

- Chief Burke said there was a 3-alarm condo fire at the Yachtsman Condo complex on Ocean Street and fortunately there was no spread at the Hyannis Yacht Club. There were 2 engines in the firehouse. We had personnel at the location within 5 minutes. Overall the control of the fire went very well. Chief Burke further stated that after the incident he and his supervisors analyzed the actions/decisions taken during the fire to study what worked and where the areas of improvement are needed
- Captain Webb agreed with Chief Burke about the planning that goes into being ready when an emergency occurs. He stated there are always areas of improvement, but he concurred with Chief Burke that overall this condo fire operation was a job well done
- 1 FF strained his back during the fire
- Chief Burke said call volume is up about 10% over 2021, that is a substantial increase from last year; right now HFD is tracking at about 6466 calls
 - The pump test will be completed this week
- We continue to make sure that the schools are managing chemicals to hopefully avoid any accidents involving chemicals like at the recent incident at the YMCA
- Captain Webb stated the 2nd run of interviews is in process for the open positions; we have had 5 informal sit-down interviews; groups of interviews tomorrow and we will send out conditional offers. In summary, there are some local candidates; some of the candidates are paramedics
- So conditional offer will depend on final steps of the interview process
