A quorum being duly present, Commissioner Cronin called the November 10, 2022 Hyannis Fire District Commissioner Regular Meeting to order at 7:00 PM

PRESENT: Commissioners Laura Cronin, Peter Cross, Alex Mercado, Demetrius Atsalis, and Victor Skende

ALSO PRESENT: District Clerk Treasurer TK Menesale, Captain Michael Medeiros, Town of Barnstable Director of Assessing Division R. Lane Partridge, and Recording Secretary Colleen Murphy

NOT PRESENT: Chief Peter Burke

I. OPEN SESSION:

- Commissioner Cronin took the meeting out of order for tax classification. We will need to vote at a later meeting on this item, as there was insufficient public notice. The District provides two week notice in the newspaper, for a public meeting regarding a tax classification hearing, we will hear the presentation, but will not take a vote.
- Director Partridge began presentation on the FY 2022; Based on the calendar year, 2021 property values experienced tremendous growth; the property purchase level declined in 2022; there was a double growth for turning commercial property to personal property (60%); The tax rate was \$2.93, basically, when property values rise then the tax rates tend to go down.
- In 2021, the residential percentage was 59% to commercial's percentage of 41%.
- Director Partridge stated the minimum residential factor was 83%.
- The board discussed these findings from the Town of Barnstable's Assessing Division
- Commissioner Cronin asked if we stay the same single tax rate AS IT IS NOW.
- Director Partridge provided an explanation of what the information on the handouts represented.
- Director Partridge asked if the commissioners could vote tonight to be in line with the deadline for the Town Council, Commissioner Cronin stated we could not, because the notice in the paper was not two weeks for this meeting date, and we will schedule a special meeting once we can accommodate that timing.
- Director Partridge indicated it was 48 hours and will check with Town of Barnstable lawyer to see if there needs to be a newspaper posting.
- Commissioners discussed that we will keep to our historic two week printed notice communication to the public for rate classification, which is two weeks in the newspaper. Director Partridge will check and touch base with Commissioner Cross for when the newspaper posting will occur.
- Commissioner Cronin stated we cannot do a provisional vote right now. Going forward, she stated we will make sure to send the required information to District Clerk Treasurer Menesale.

- Chief Burke said there were 4 candidates given conditional offers contingent on the results of the testing scheduled for early 2023; 20 medics applied for these open positions
