A quorum being duly present, Chairperson Cronin called the December 3, 2024 Hyannis Fire District Commissioner Special Meeting to order at 6:02 PM

Upon a motion duly made and seconded it was voted to take the special meeting out of order to discuss the Agenda Item 6a. Tax Classification with Tax Assessor

- John Curran, Director of Assessing for the Town of Barnstable presented the FY25 Tax Classification hearing; this is a review of the property tax levy shifting options, this hearing is not a meeting to set a tax rate
- The FY25 total valuation of all classes and property is \$5,792,005,00
- Real estate valuation information is based on historical data
- Based on 2023 real estate sales data; there is an improving real estate market; the Director of Assessing Curran presented the different options available to the HFD
- Director of Assessing Curran went through some examples highlighting the impacts of each option on the district and its residents such as looking at a unified rate for an average single-family tax rate at a 6.51 rate, a tax rate of \$2.68 per \$1000.00; this rate would result in a tax bill of \$1700.00 which would be the max rate option
- The board discussed the various options and these options' impacts to the district and its residents
- HFD has usually chosen the split rate to balance the tax needs of residents and commercial
- We are currently at a 1.39 tax rate; the district's real estate composition is split between 74.9% residential and 25% commercial, not including exempt properties like the hospital, etc.
- Last year the district chose the 1.39 tax rate shift option, the average single-family tax bill on average at this rate was \$1500.00

9. CHIEF'S REPORT:

- Chief Burke said the new FFs were assigned to their shifts, respectively
- 4 of the 6 new hires have been signed off as approved for duty and the onboarding process; Liveburn training will be next week in New Bedford and it is open to all current HFD FFs
- There will be 4 days of door training; the grant received by the HFD covers this training; the door training also covers topics such as how to access different lock types and how to cut different types of doors open with the various power saws available to HFD
- The Local 2172 Union President Jeff Erving has not been sent the evaluation articles for FY25, but in FY26 the evaluation articles will be modified possibly by incorporating a 3-step evaluation process
- Chief Burke reminded the board December 3, 2024 is the 25th anniversary of the Worcester Fire tragedy
- Chief Burke said some of the lessons learned from the Worcester Fire tragedy are understanding how our FFs' air bottles are doing in the midst of managing a fire and being able to notify FFs to back out of managing a fire if the FFs' air is going down
- The board discussed the improvements to FF gear for increased health monitoring during an emergency and the very active fire situations for the HFD in the last few weeks
