A quorum being duly present, Chairperson Cronin called the March 13, 2025 Hyannis Fire District Commissioner Regular Meeting to order at 7:02 PM

PRESENT: Chairperson Laura Cronin, Commissioner Peter Cross and Commissioner Alex Mercado

ALSO PRESENT: Chief Peter Burke and District Clerk-Treasurer TK Menesale

ABSENT: Commissioner Demetrius Atsalis

I. OPEN SESSION:

1. MOMENT OF SILENCE for COMMISSIONER VICTOR SKENDE:

- Chief Burke commended the FFs for prepping the space for the service for Commissioner Skende; they put in a lot of effort preparing the station, cleaning, and they put their best foot forward

2. MINUTES:

- The meeting minutes will be voted on in a future meeting

3. CORRESPONDENCE:

4. PUBLIC COMMENT:

- None

5. STREET LIGHTS:

a. Dunn's Pond

- No update, as Commissioner Atsalis was not able to attend this meeting

6. OLD BUSINESS:

a. Budget

- Commissioner Cross noted we may need to increase the electricity line item, costs have increased; he also asked about the Holiday Buy Back line increase while sick time buyouts decreased almost equally

- Chief Burke noted these items are based on projected retirements

7. NEW BUSINESS:

- None

8. BUILDING REPORT:

- None

9. ITEMS NOT REASONABLY ANTICIPATED BY THE CHAIR:

- None

10. CHIEF'S REPORT:

- Chief Burke noted we are working on a COVID reimbursement and unsure if payment will be made; \$1.7M is due from the Commonwealth of Massachusetts

- Marine 1 is in evaluation for replacement or refit, and our compressor, which is 20 years old, is also being evaluated

10. CHIEF'S REPORT (continued):

- The board discussed placing the replacement option as a warrant article and identifying the capital expenditure as possibly funded by free cash or raise and appropriate
- Chief Burke suggested they may to downsize the boat, as the learning curve to driving Marine 1 is substantial, and we do not need 2 large boats
- Commissioner Cross suggested an outboard motor might be more desirable
- Chairperson Cronin asked for a discussion on Marine 1 to be placed on the agenda for the next meeting
- Chief Burke said they should have a presentation on Marine 1 available
- Chief Burke said Administrative Assistant to the Chief, Kelly Foley, is no longer with the HFD office; District Clerk-Treasurer Menesale and Sara French, Administrative Assistant Fire Prevention, were supporting office needs and helping with insurance changes; Chief Burke said District Clerk-Treasurer Menesale and he are now processing payroll
- Chairperson Cronin asked what Chief Burke's plans were for replacement; Chief Burke said he would work with the Chiefs on making a posting in the next 2-4 weeks; Chief Burke is reviewing, re-shaping the position
- Chairperson Cronin said the board would like him to have a replacement online before summer 2025; the board would like Chief Burke to be able to focus on other issues than payroll
- The board discussed the Tower proposal; the entity inquiring about renting space on the HFD Tower provided an evaluation of what the add-on would look like; Chief Burke shared the proposed diagram with the board
- Chairperson Cronin does not support renting out the space and she felt that the projected income was not significant enough to entertain this offer
- Chief Burke asked if there was an income figure that would be motivating
- Commissioner Cross said he was interested in the details
- Chairperson Cronin does not support private enterprises renting our public space and she noted that potential health issues were among her concerns
- Chief Burke discussed hose replacement; some of the older hoses were delaminated, and blockages were occurring; a new hose liner is impregnated in the layers of the new hose; 1200 feet of new hose is to be replaced, and we have been ordering the replacement in anticipation, we have the hose in house
- The board discussed coupling types
- An after-action review of the Falmouth Road fire was scheduled for Friday, March 14th; other fire chiefs discussed cross-fire department engagement; Chief Burke mentioned that more than 60 outside support personnel were involved in the 2-alarm fire, so coordinating the feedback would be a worthwhile project
- The new Pierce Fire Truck is scheduled for delivery at the end of the summer
- Run volumes are tracking about last year, with the year 2020 being the highest call volume year
- The board reviewed the changes District Clerk-Treasurer Menesale made to the "About Commission" webpage, adding "In Memoriam" after late Commissioner Skende's name and posting his memorial photograph on the page; the board supported the changes and agreed to the posting remaining up for 6 months to a year
- Chairperson Cronin requested for the next meeting agenda we put Commissioner terms on the agenda and have a By-laws discussion
