## 1. MINUTES:

- The March 9, 2023 Meeting minutes and the April 13, 2023 Meeting minutes will be voted on at the next meeting

#### 2. CORRESPONDENCE

- District Clerk Treasurer TK Menesale stated that retired HFD Commissioner Dick Gallagher thanked her for her sending him the requested MedEx reports and he also requested a copy of the annual report and warrant
- 3. Chairperson Cronin said that HFD information is public and the public needs to have access to this data
- 4. Chairperson Cronin asked District Clerk Treasurer TK Menesale to keep a log of requests for public HFD information to make sure the public's needs are being met

## 7. BUILDING REPORT

- Chief Burke stated that Convergent has been working on the additional RFID items
- Chief Burke also mentioned that the Commonwealth has a solar panel initiative with Select Energy which would have no cost to HFD to get solar power to help offset energy costs for the building costs: The Town of Barnstable is currently working with Select Energy
- FF Mike Dalmau stated that Select Energy will own the equipment so there will be no maintenance cost for the HFD

#### 9. CHIEF'S REPORT

- Chief Burke said call volume is still tracking a little under last year, but it is still ahead of previous vears
- The new Assistant Fire Chief and the new Deputy Chief have both started their positions
- Captain Webb will be moved to B Shift this Sunday and the open position of Captain of Fire Prevention will be posted tomorrow; The ad will be open for 30 days
- Chief Burke stated the quint fire truck order is in, a quint fire truck means it is a five- abilities vehicle and we met all the deadlines to get the best price
- Chief Burke said the total cost for the fire truck was \$1.608 million
- Assistant Chief Storie discussed PFAs, its dangers, and how the HFD is disposing of the PFAs foam
- The board discussed what new products are available to replace the PFAs foam and the future concern on how to clean any fire trucks that had used the PFAs foam within its tanks and hoses
- We have started our end-of-year reduced spend
- The board discussed the current boat situation and which current boats are in the process of being evaluated
- We sent 2 FFs to training in Rockland, MA as the Rockland Fire Department had a grant
- Cape Cod Healthcare at Cape Cod Hospital is taking part its building down so HFD is taking this opportunity to do some training there
- 2 HFD officers are presently attending the Fire Department Instructor Fire Conference
- Fire Safety is continuing to work with Cape Cod Hospital on its evacuation plan and HFD is also advising the Town of Barnstable on the new Main Street facade
