- 5 Commander Boards have been delivered to the fire house which were given to HFD via a grant
- Chief Burke stated he had spoken to Chairperson Cronin earlier in the week to let her know there were slight modifications needed in the budget due to an error; Chief Burke handed out the corrected 3.2 version of the budget; the fixed adjustments lowered the budget about \$96,400k
- Promotional Written Exam will take place in the HFD Training Room on Monday, May 2, 2022 and the Assessment will take place upstairs in the fire station Tuesday, May 3 Friday, May 6, 2022
- Chief Burke gave accolades to both Deputy Chief Kristofferson and Capt. Story for running a successful and well-received candidate preparation for the assessment center training; this candidate preparation clinic would have cost more money but instead Deputy Chief Kristofferson and Capt. Storie ran this clinic and saved the department money that would have gone to a consultant
