5. OLD BUSINESS:

Annual Meeting:

- Chairperson Cronin thanked all who helped make the Annual Meeting a successful meeting
- Chief Burke asked if the next Annual Meeting should take place in the training room; Chairperson Cronin said the board will review the Annual Meeting's logistics as we get closer to next year's Annual Meeting planning stages
- Commissioner Cross asked for the Annual Meeting notes to review any suggested improvements for the 2025 Annual Meeting

Elections:

- The Board's officers position elections are scheduled to take place on June 13, 2024
- Chairperson Cronin will be reaching out to the new Moderator to go over the Moderator's duties such as assigning the By-law Committee, what the role of the Moderator is at the Annual Meeting, etc.
- The board agreed with receiving training from the HFDC legal team to ensure the election runs smoothly and correctly; this training should be done during June 2024, if possible; this training would be good to have completed before the end of summer 2024 especially if a special meeting is needed

- 7. BUILDING REPORT:
 - Chief Burke said the tower anchors have been installed
 - Chief Burke stated he is still waiting for Alan Giles from Solect Energy to send him the requested copy of his solar presentation
 - Chief Burke said with the limited amount of capacity that will be created by the proposed solar panels' installation, Chief Burke questioned whether the proposed Solar project was worth it as there seems to be little benefit for HFD versus the costs incurred by the HFD for this particular project
 - The board discussed pursuing or not pursuing the proposed Solar project
 - Per the board deciding not to pursue the proposed Solar project, Chief Burke said he will explore options regarding other solar projects

9. CHIEF'S REPORT

- Chief Burke said we are 150 calls under compared to the May 2023 call volume; this call volume drop is normal as our calls usually increase at the end of June
- Assistant Chief Storie stated hiring was advertised starting on May 20 and this notice will run to June 3rd at 4 PM; Assistant Chief Storie said 15 resumes and cover letters have been received as of today; there could be up to 4 open positions that need to be filled
- Assistant Chief Storie will be officially retiring on July 3rd; over the next couple of weeks, we will have testing results to share with the board regarding this future open position
- The Quincy hull has been removed from the back lot; Marine 2 has been painted; the motor started with no problems; there are some final tuning to be completed; Marine 2 should be in the water in the next 2 weeks; Chief Burke asked the board if they could have an official launch gathering; the board agreed to having an official launch event for Marine 2
- Chief Burke stated the 9/11 Tower Memorial will be happening in July; this memorial will be on the agenda for the next meeting for the board to vote on; the memorial will be on the lot adjacent to South Street
- The board discussed if Main Street should be a 2-lane street or a 1-lane street; the board discussed the possible impacts to the fire district if the airport rotary is updated; Chief Burke stated that the HFD is focused on doing its job and the HFD will adapt to any logistical changes it needs to in order to provide the best emergency services to its district
