6a. Succession Planning:

- Assistant Chief Storie said regarding the deputy's exam, all 3 examinees passed, and all scored well on it; he is proposing that Gregory Dardia be promoted to Assistant Chief when he retires
- The Training Captain position is open 3 Applicable
 There are 72 applicants; we are interviewing 24 people Monday (06/24) and Tuesday (06/25) the ad for this open position will be posted in the paper

6b. Gift of Funds Release

- The movable monument for 9/11, it was requested we provide \$15k funds towards this monument, these requested funds will be replaced by donations raised for the memorial; this movable monument benefits veterans and first responders from 9/11
 - Presently, we have \$38k in the Gift of Funds
 - This memorial will be here July 27 and July 28

6c. Insurance Presentation:

- The insurance policy must be approved by July 1, 2024
- Chief Burke said, he and District Clerk Treasurer Menesale can review the insurance policy and if there are any issues then he will reach out to the board; the insurance policy needs to fall within HFD's budgetary constraints
 - The board discussed the insurance policy and the amount allotted for the insurance policy in the budget
- Commercial auto is going up so auto claims have gone up in all industries, this factor could increase some of the deductibles; the items concerning injured on duty, workers comp, and cyber all are up \$221,602 currently
- The overall increase is \$12,400 due to the increasing deductibles which will save in the overall cost by saving
- The board discussed the increasing deductibles; the representative from Dowling and O'Neil further detailed the impact of possible bad actors on cybersecurity
- The deductibles are \$3000; District Clerk Treasurer Menesale will email Dowling and O'Neil's representative with the commissioners' answer
