- Chief Burke stated the glass door repair is in process

- All mentioned issues are being worked on and they are all moving forward

#### 7. ITEMS NOT RESONABLY ANTICIPATED BY CHAIR

#### 8. CHIEF'S REPORT

- Chief Burke thanked Deputy Chief Storie for managing the 9/11 Memorial which went well; Deputy Chief Storie did a great job managing this event
- Deputy Storie discussed the hiring process for the 4 open positions. Over the last few weeks we have been interviewing candidates. In fact there have been 12 interviews over the last 2 days. Presently, we are making our recommendations to get them through to the next stage of the interview process. In summary there are 20 medics and 40 EMTs who applied for these open positions. There is a mixture of candidates with various levels of training. Overall the candidates have high level of skills and experience. After the 2<sup>nd</sup> interview with the 12 we interviewed recently, we will make our recommendations.
- Chief Burke said we are constantly trying to refine the interview process. There are some challenges we face as we try to improve the interview process. For example, the Cape-wide written exam, which was the basic hiring tool at one time, went away due to its format. One improvement we are thinking of utilizing is a computer skills assessment tool to aid in this interview process. In brief, the interview process is constantly being refined to make sure that there are no barriers to applying and that the candidates are assessed in the most effective method which illustrates their skills and highlights any areas they might need to improve
- Deputy Storie stated that this a great sign when you see the number of candidates who apply for these positions for the HFD; the desire to work for the HFD reflects the reputation of this organization
- A new ambulance was delivered; it has scheduled to be serviced next week or the week after
- Community Safety Day (9/22/22) we had over 200 attendees and this event went well. Great job all around.

Commissioner Cronin commented on the fabulous job that the HFD did for the Community Service Day event,

Commissioner Cronin noted that the HFD had a strong presence in the front of the event area.

- Chief Burke said September 2022 and October 2022 had a schedule of training which is not unusual for these months.
- We have new initiatives. For example, we received our first Net radios (federal cell provider radios). We are focused on maintaining techniques so that our FFs are able to immediately fix any challenges like if the WIFI goes down.
- Chief Burke pointed out that the equipment is useful, but it can be complicated. The new radios which were purchased a few years ago are complex. For example, these radios have 1600 channels which adds to the complexity when FFs utilize them in an emergency. Therefore, the HFD is focused on making sure its FFs are trained on this useful and complex equipment. Chief Burke wants to make sure the FFs are able to utilize the equipment to the fullest extent possible.

Commissioner Cronin pointed out that it is amazing that there is equipment available that has the ability to perform these challenging tasks and that the HFD leadership makes sure that its staff is able to meet and exceed these challenges

- Commissioner Cronin stated that the flu shot clinic will be 2-4 PM
